GENERAL TERMS AND CONDITIONS OF CONTRACT

Art. 1 - SCOPE OF APPLICATION - This regulation has specific contractual relevance for all the subjects admitted to exhibit and for those who have relations with the company Pubbligreen S.r.l. , to be reported textually in each participation form signed by the representatives.

Art. 2 - RETIREMENT RIGHT - The client has the power to rescind this contract by expressing this decision within 10 days from signing the contract and exclusively with registered letter A.R. . Otherwise, the contract will be considered perfected.

Art. 3 - DEPOSITS - Each client must pay 30% of the total amount when signing the contract. The amounts paid by the participants do not constitute a down payment in accordance with and for the effects of art.1385 c.c., but mere advance on the agreed price. The balance must be paid by the exhibitor on the first day of the exhibition upon delivery of exhibitors' passes.

Art. 4 - RENOUNCEMENT - In case of renunciation to exhibit, beyond the terms set forth in art. 2, the participant is required to pay a penalty equal to the agreed amount. All communications must be in writing by registered letter A. R. or P.E.C. , verbal form or by fax is not allowed.

Art. 5 - LOST PAYMENTS - The Pubbligreen s.r.l., in the event of non-payment by the exhibitor within the established deadline, has the right to retain the goods on display. After 15 days from the missing balance, the Pubbligreen s.r.l. has the right to proceed with the sale of the goods withheld until the complete recovery of the credit, plus default interest equal to 12% per annum (calculated up to the day of sale of the goods) and incidental expenses incurred for that operation.

Art. 6 - MULTIANNUAL CONTRACT - In the case of a multi-year contract, the contract is to be considered as the only obligation divided by year. In case of default, even for one year only, the debtor will lose the benefit of the installments and Pubbligreen s.r.l. will be authorized to request the full amount agreed for all annuities.

Art. 7 - ASSIGNMENT OF EXHIBITION AREAS - In the allocation of the exhibition areas, the product sector will be taken into account. Each exhibitor may, within these sectors, reserve the space at the time of signing the contract. Pubbligreen s.r.l. reserves in any case the right to move or reduce the individual exhibition areas if it deems it appropriate. In this case no compensation or other indemnity will be awarded to the exhibitor.

Art. 8 - OCCUPATION OF AREAS - The client is required to take possession of the stands assigned to him at least 48 hours before the start of the event. Otherwise the Pubbligreen s.r.l. will be free to sell the stands to third parties, without prejudice to the client's obligation to pay the agreed price or penalty.

Art. 9 - EXHIBITION OF GOODS AND RESTITUTION OF THE EXHIBITION AREAS - Each company undertakes to keep the exhibition of its products on the stand assigned for the duration of the event in which it participates, remaining responsible for any eventual premature abandonment of the exhibition area. Starting at 08.00 the day following the closing of the exhibition, each exhibitor will proceed to remove promptly, but not more than two days, at his own care and expenses, all the products installed, leaving the exhibition areas completely free from people or things. For the exit from the exhibition center of any material must, however, be issued by Pubbligreen s.r.l. receipt of payment of any sum due for participation in the event. Pubbligreen s.r.l. assumes no responsibility for the goods, materials and anything else left unattended by the exhibitors at the end of each event. After the aforementioned two-day deadline, if the exhibition area is still occupied by material owned by the exhibitor, the material will be deemed abandoned and Pubbligreen s.r.l. will provide for the removal and storage of the same.

Art. 10 - LIABILITY FOR DAMAGES - INSURANCE - The exhibitor is responsible towards the Pubbligreen s.r.l. and the managing authority of the exhibition spaces of all damages caused by any direct or indirect cause, of its employees or third parties, without exclusion or limitation of any kind. The exhibitor must be insured against all risks, including those of theft, fire, infiltration damage and rainfall and responsibility towards third parties. The company is entitled to the only insurance r.c.t. for the whole fair district.

Art. 11 - REFERENCE, REDUCTION OR SUPPRESSION OF THE MANIFESTATION - Pubbligreen s.r.l. reserves the unquestionable right to change the date of the exhibition by prompt communicating notice to the exhibitor. In case of cancellation of the exhibition, the exhibitor will be entitled to a refund of the amount already paid with the signing of the contract, excluding any further indemnity.

Art. 12 - SURVEILLANCE - Pubbligreen s.r.l. provides throughout the day of the event, as well as for all days scheduled for the preparation and clearance out of the exhibition areas, a general night surveillance service within the exhibition center. However, it does not assume any responsibility for any theft and / or damage that may occur due to the work of third parties, both during the day and at night. During the hours set up for the set up and the clearance out, as well as during the opening hours to the exhibitors and to the public, each participating company is obliged to supervise its stands either directly or by employees.

Art. 13 - JURISDICTION - Notwithstanding the rules on the competent Court in the event of disputes or proceedings relating to this contract, the parties expressly and jointly agree that the only Competent Court is that of Lecce.

Art. 14 - TIMETABLES - In relation to the scheduled timetable of each exhibition, exhibitors are required to keep the stands equipped with personnel that will be able to access and leave the exhibition center half an hour before opening and half an hour after closure to the public.

Art. 15 - General Data Protection Regulation (EU No. 679/16) - Information is collected for commercial and promotional purposes only, data will be processed in accordance with the General Data Protection Regulation (EU No. 679 / 16) in order to promote offers and products. They may be communicated to banks for the management of collections or payments, to professionals / consultants / external consultants and to the Financial Administration for the fulfillment of legal obligations, to companies specialized in marketing, printing and enveloping services or used by Pubbligreens.r.l. for automatic delivery of fax or e-mail. The data will not be disclosed. The client has the right to express his consent or not; in lacking of consent, the service will not be executed. It can be exercised at any time the rights recognized by the General Data Protection Regulation (EU No. 679/16) (consult, modify or delete its own data) by reporting it to the data controller domiciled at our company at tel.0832 / 311425 or by sending an e-mail to the e-mail address bari@externaexpo.it
